### **Data Collected Automatically**

When you visit and use our Site, we may automatically collect and store the following information:

1. IP address;
2. Location;
3. Hardware and software details;
4. Clicked links;
5. Content viewed; and
6. Any information our services require such as a shipping address, phone number, or information about the customers original product..

#### Data Collected in a Non-Automatic Way

We may also collect the following data when you perform certain functions on our Site:

1. First and last name;
2. Email address;
3. Phone number;
4. Address;
5. Payment information;
6. Auto fill data; and
7. Reviews.

This data may be collected using the following methods:

1. Customer inquiry info such as serial numbers or models of thr;
2. Placing order; and
3. Asking customer to leave a review.

#### **How We Use Personal Data**

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect automatically is used for the following purposes:

1. To ship orders to our customers and to better our advertise our site..

The data we collect when the user performs certain functions may be used for the following purposes:

### **How Long We Store Personal Data**

User data will be stored until the purpose the data was collected for has been achieved.

You will be notified if your data is kept for longer than this period.

### **How We Protect Your Personal Data**
